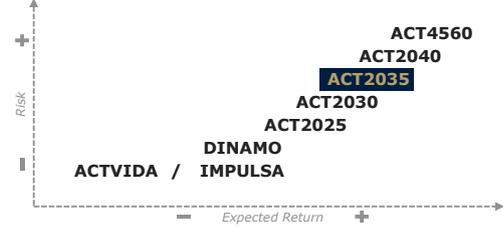

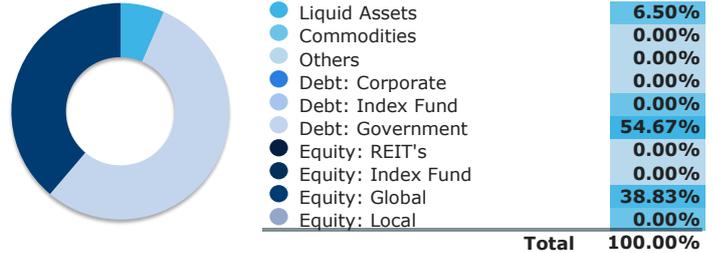

ASSET CLASS BREAKDOWN¹

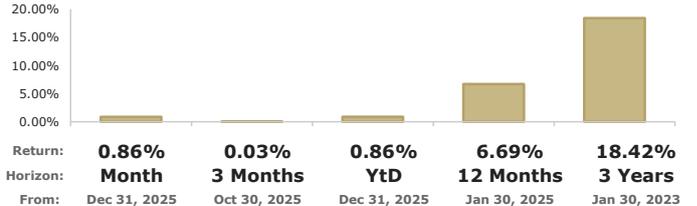
