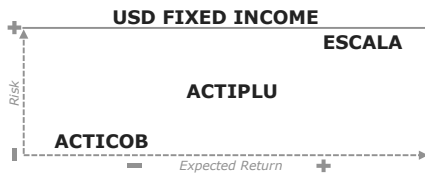

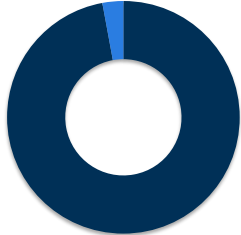

CURRENCY BREAKDOWN¹



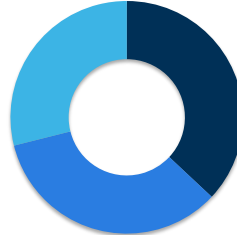

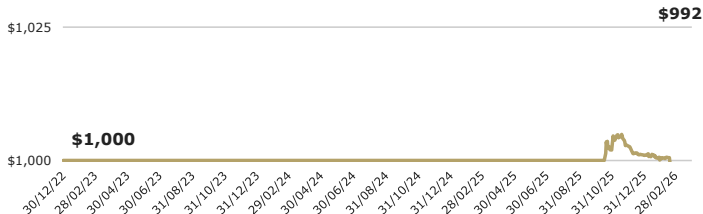

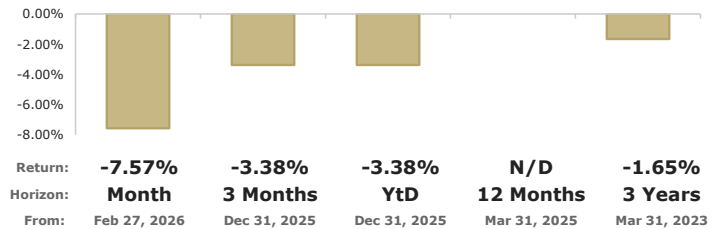
