3. Target Date Funds are designed considering a target return with an specific investment time horizon.

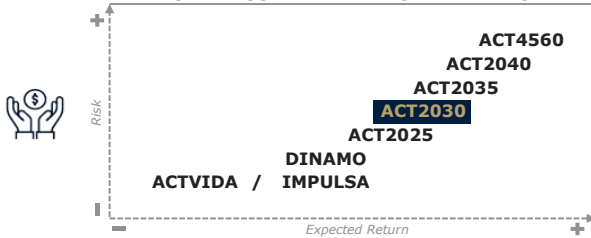

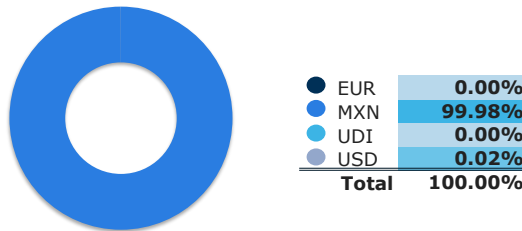
MULTI-ASSET AND TARGET DATE FUND



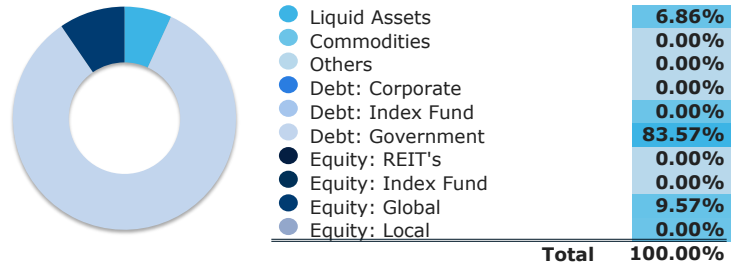

ASSET CLASS BREAKDOWN¹



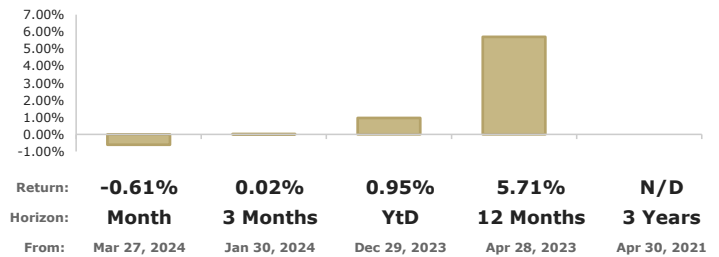
