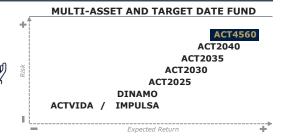

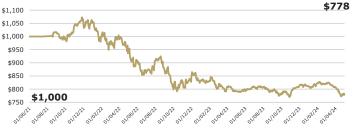


## ASSET CLASS BREAKDOWN¹
