




- 2. The Fund seeks to take advantage of peso/dolar exchange rate volatility in order to create an excess return above local debt instruments, in the long-run.




## ASSET CLASS BREAKDOWN¹


# **GROWTH OF HYPOTHETICAL** \$1,000.00 MXN<sup>2</sup>
