## FUND KEY ASPECTS



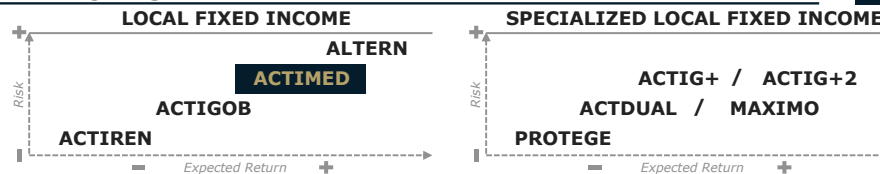
1. The Fund's objective is capital preservation, in order to maintain purchasing power in line with inflation.

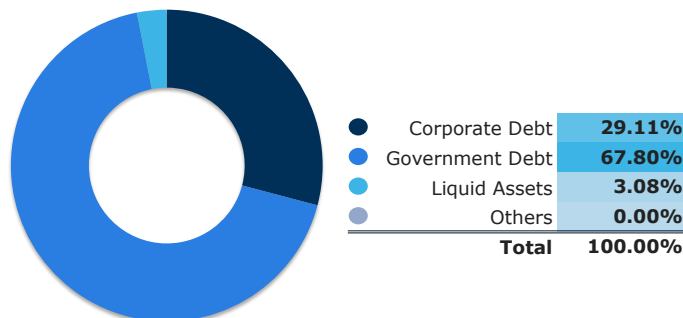

## ASSET CLASS BREAKDOWN<sup>1</sup>

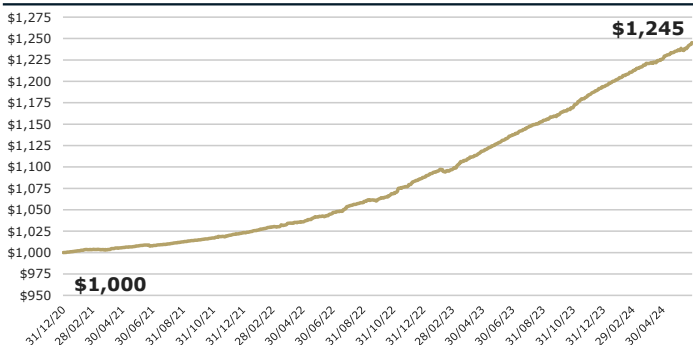

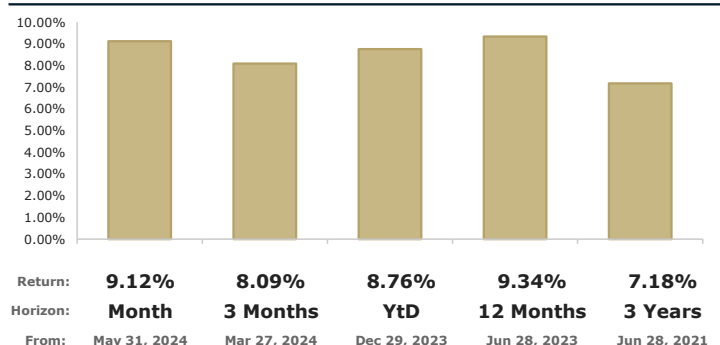
## CURRENCY BREAKDOWN<sup>1</sup>
