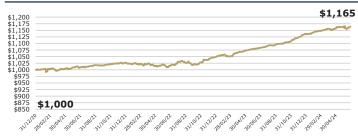


ASSET CLASS BREAKDOWN¹

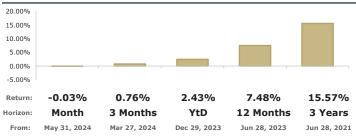
