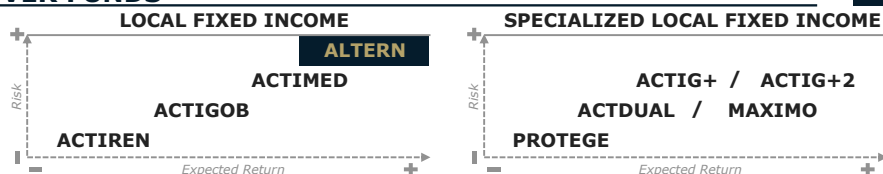
1. The Fund's objective is capital appreciation above any given CETES maturity bond (Local Zero-Coupon Bonds) in a long-term investment horizon.

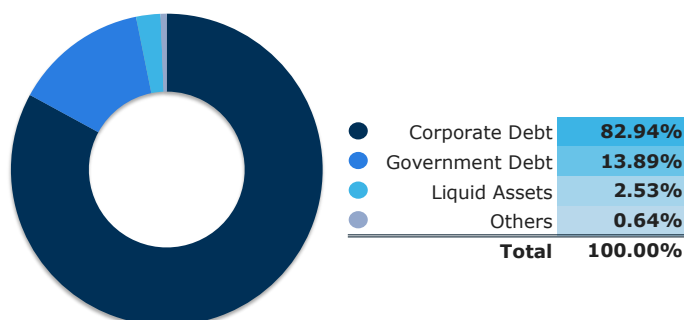

Current interest rate sensitivity

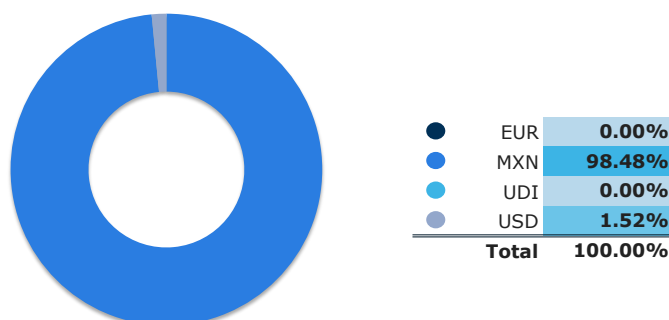


ASSET CLASS BREAKDOWN¹

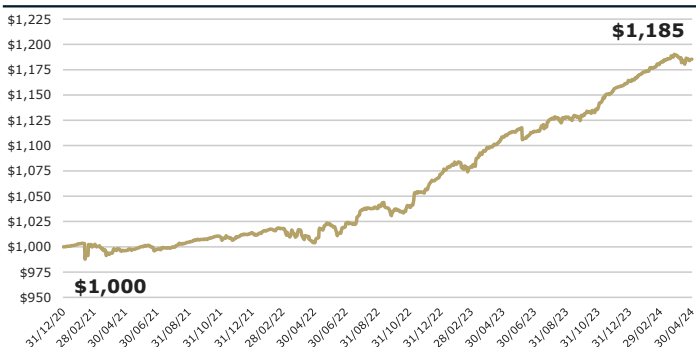

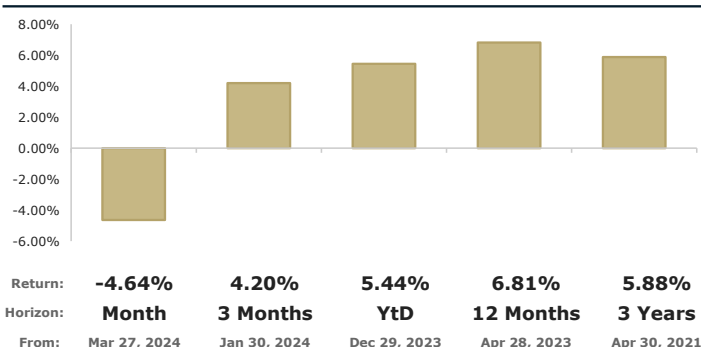
CURRENCY BREAKDOWN¹
