3. The Fund's investment objective seeks capital appreciation in the long-term, whilst simultaneously offers a personal and property protection.

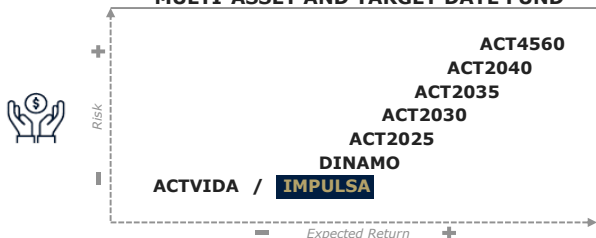

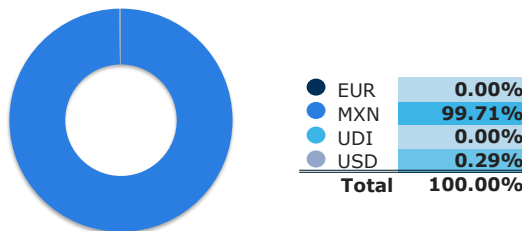

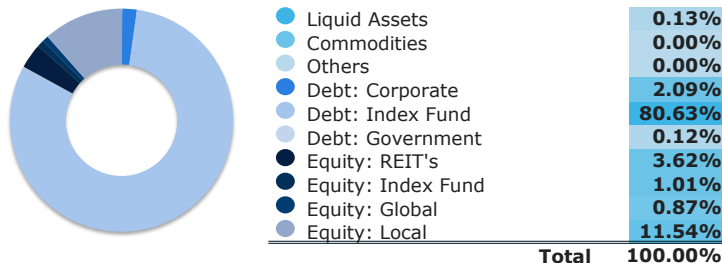

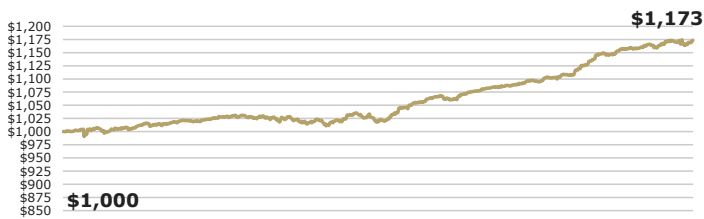


ASSET CLASS BREAKDOWN¹

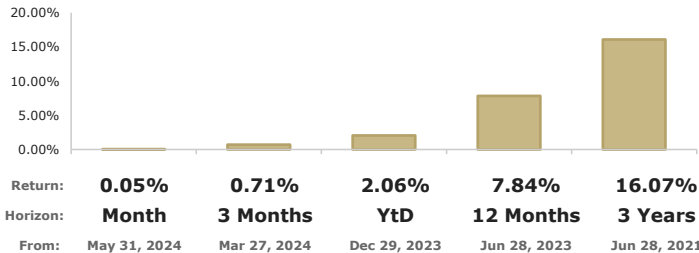
