## FUND KEY ASPECTS



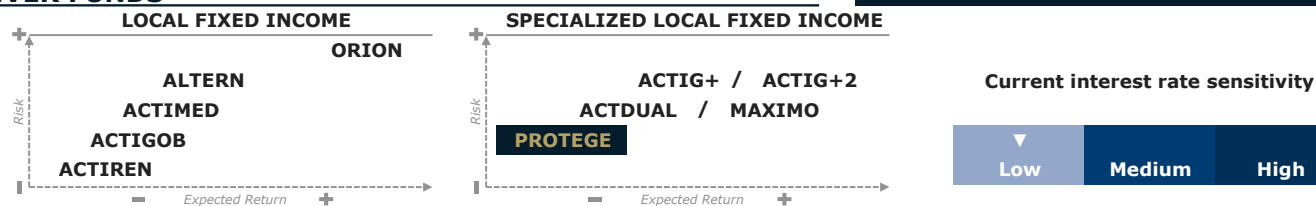
- Efficiency through accumulating UCITS ETFs, in which all interests are reinvested. As an equity fund, tax regime of 10% on capital gain, at the time of sale.

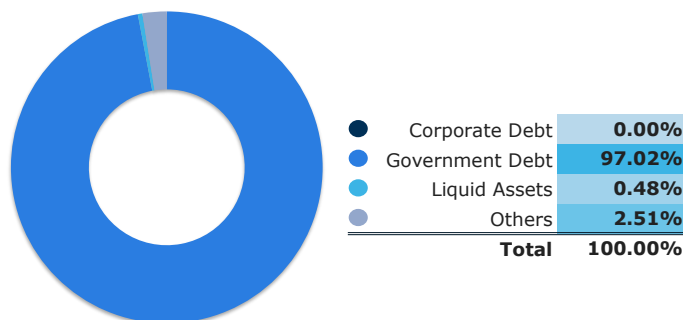

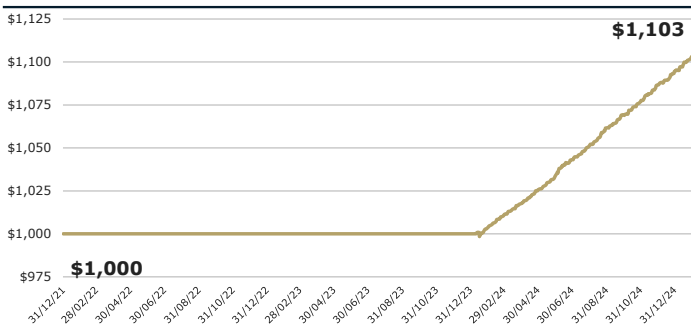


## ASSET CLASS BREAKDOWN<sup>1</sup>

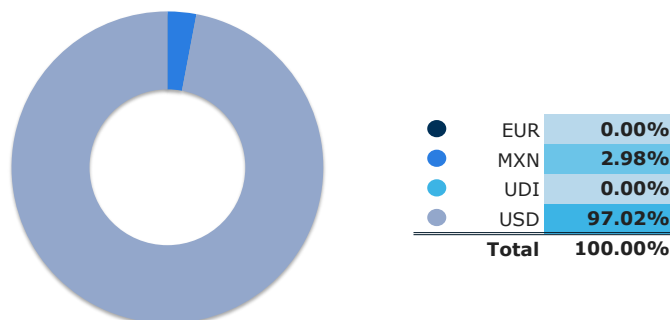

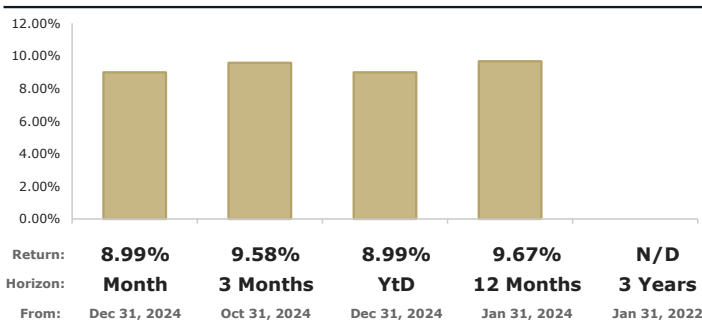
## GROWTH OF HYPOTHETICAL \$1,000.00 MXN<sup>2</sup>
