WHY INVEST IN OUR FUND?



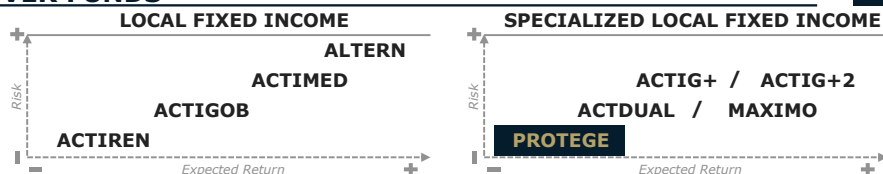

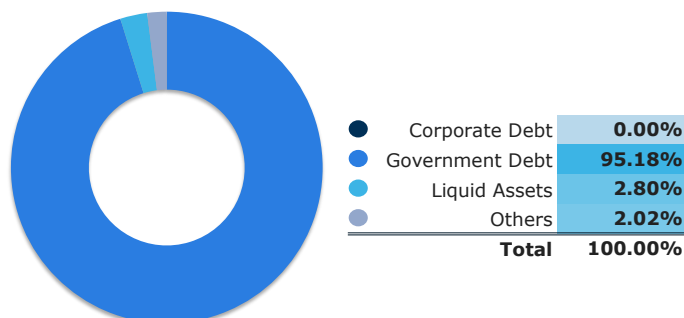

Current interest rate sensitivity

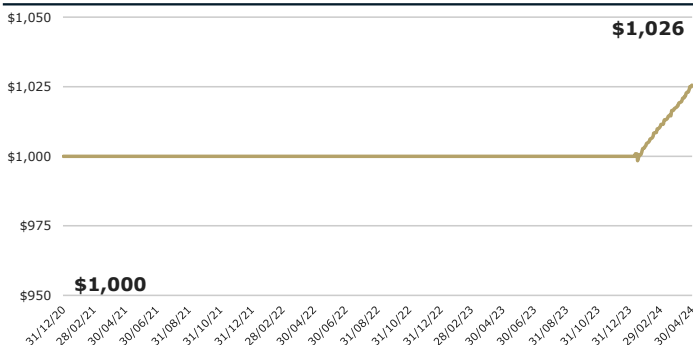


ASSET CLASS BREAKDOWN¹

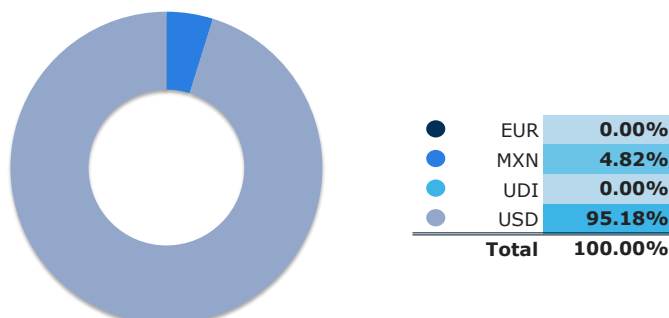

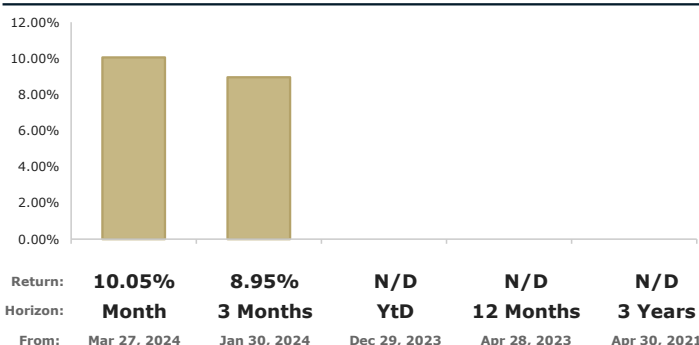
GROWTH OF HYPOTHETICAL \$1,000.00 MXN²
