## FUND KEY ASPECTS



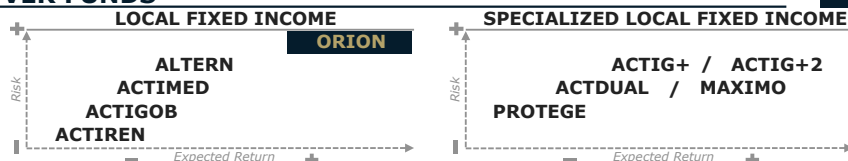
1. The Fund objective is capital growth in the long-term (at least 6 months)

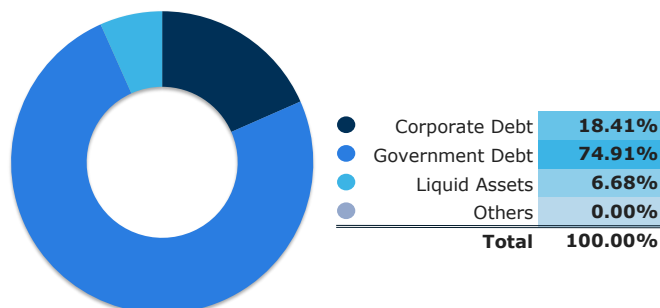

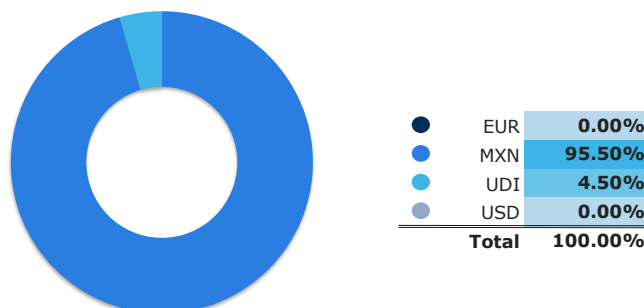
## ASSET CLASS BREAKDOWN<sup>1</sup>



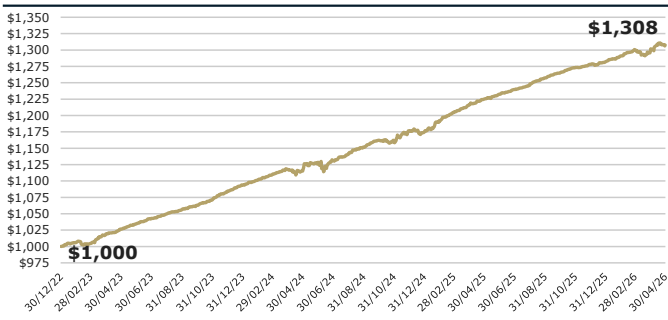

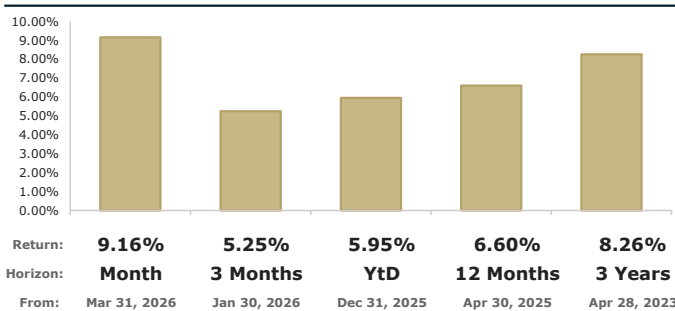
## CURRENCY BREAKDOWN<sup>1</sup>
